Thank you for your email and apologies for not responding sooner.

I will add your request to the next Roads and Traffic Agenda for consideration, the meeting is scheduled for Thursday 7th March.

However, I must explain that should the bin(s) be approved for purchase, a licence would then need to be procured before installation could take place. The bin(s) would then be added to the winter plan whereupon they would only be filled by WSCC in the event of a severe weather incident. Until that time, the bin(s) would remain empty. WSCC only provide grit once per year. For more details, please see the Winter Advice page on our website, which has links to various sources of information.
