Thank you for your email. My apologies for the delay in reply which has been due to pressure of other work. Please find below Joanne's comments in respect of the replacement shed which she forwarded to me yesterday:

'Part 12 of the Town and Country Planning General Permitted Development Order 2015 relates to development by local authorities.

It states the following would be permitted development:

"A. The erection or construction and the maintenance, improvement or other alteration by a local authority or by an urban development corporation of—

(a) any small ancillary building, works or equipment on land belonging to or maintained by them required for the purposes of any function exercised by them on that land otherwise than as statutory undertakers;"

However, this states that any small ancillary building, works or equipment shall not exceed 4 metres in height or 200 cubic metres in capacity.

Therefore, I am of the opinion that provided the building meets the above stipulations then planning permission will not be necessary.

The above represents my informal view only based on the information contained in your enquiry. Should you require a formal determination as to whether planning permission is required for your proposal then it is open to you to make an application to this authority for a Certificate of Lawful Development, under Section 191/192 of the Town and Country Planning Act 1990, as amended by the Planning and Compensation Act 1991.
