The quote is for locating, digging and installation of inspection chambers.

To find the pipe I will dig a small trench parallel to northern hedge inside cemetery. Once found the trench will be continued east to the other drain.

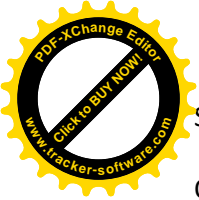
A new inspection chamber will be placed over the pipe to catch the incoming water. When the water reaches a certain height it will travel along new pipe to existing chamber, which is then taken to stream.

This will stop water coming through cemetery in the old pipe so burials can continue in that area.

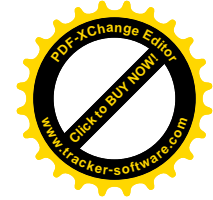
I am positive i can find the location of the pipe in this area as it runs north/south through the burials and i plan to dig a trial trench east/west by the hedge.
