RT027 To receive apologies for absence

Cllr Ceccherini offered his apologies which were accepted.

RT029 To approve the minutes of the meeting held on 12th December 2024

RT031 To receive an update regarding the proposed 20mph zone within Cuckfield along London Lane/Broad Street/High & South Street

The committee was waiting to receive an update from Cllr Bradbury regarding the Strategic Traffic Assessment survey with WSCC. The committee noted their worry about the time this survey will take to be completed.

RT032 To receive an update regarding the implementation of a 30mph zone from the roundabout at Tylers Green through to the Bolnore roundabout

The committee was waiting to receive an update from Cllr Bradbury regarding the Strategic Traffic Assessment survey with WSCC. The committee noted their worry about the time this survey will take to be completed.

RT033 To consider the purchase of another set of SIDs

Committee resolved that Cllr White would report back with some quotes and agreed to add this item for discussion to the next F&GP meeting to consider adding the SIDs purchase to the budget.

Cuckfield Parish Council adopted the General Power of Competence on 18th May 2023, all decisions made during this meeting are done so under this power.

RT034 To consider the purchase of new wooden posts to replace the damaged posts located on the verge at the top of Broad Street

Committee agreed to replace the rotten posts on the verge at the top of Broad Street and to go ahead with the purchase.

RT035 To consider CPC maintaining the overgrown hedges along the footpaths, instead of waiting for WSCC highways to cut them back

Committee agreed that this responsibility should remain with WSCC and encourage the residents to report any overgrowth obstructing the paths to Love West Sussex.

RT036 To consider encouraging more residents to get involved with speed watching

Committee noted the lack of engagement from residents and agreed to mention speed watching at the APM on 27th March to gain more interest from the residents of Cuckfield.

RT037 To consider encouraging the reporting of potholes by residents

Committee noted that residents should get involved more with the reporting of potholes and agreed to mention this at the APM on 27th March to encourage the residents to report potholes directly to WSCC.

RT038 To receive an update on the flooding issues at Hanlye Lane

Committee agreed to request some feedback from WSCC to understand what work had been done.

RT039 To note/discuss any accidents added onto the spreadsheet (circulated)

RT040 To note items arising after the preparation of this agenda which the Chairman agrees to take as urgent. Such matters will be for noting only or deferral to a future meeting only

Cllr White raised a concern shared by a resident about the risk of accidents when approaching the tylers green roundabout from Haywards Heath direction. There was an entrance on the immediate left, but drivers were looking to the right for traffic coming round the roundabout. Since two accidents had recently happened in that location, the resident had suggested whether a warning "concealed entrance" sign could be added. This concern had been reported to WSCC.
